- c. Tax Clearance;
- d. Audited Financial Statements; and
- e. PhilGEPS Platinum Registration Certificate/ITR


In lieu of the above documents or its acceptable equivalent documents, you may still submit your PhilGEPS Platinum Certificate of Registration and Membership, at your option.

Bid Security may be dispensed with. However, Warranty Security is required in Direct Contracting among other alternative methods of procurements as stated in Annex "H" Letter M of the 2016 IRR of RA 9184.

The Philippine National Police Special Action Force reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
